

The Deposit-at-call or Demand Draft must be submitted along with the tender.

Tender documents shall be issued on payment of **Rs.1,000/-** (Rupees one thousand) only in cash/ Demand Draft(Non Refundable) on any working days as specified above on production of documentary proof of registration of the firm, Pan Card, valid Labour License, professional tax clearance certificate along with the application.
