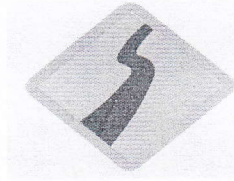

The Empowered Officer, Tripura RRDA on behalf of Governor of Tripura invites the percentage rate bids in electronic tendering system for construction of road under Pradhan Mantri Gram Sadak Yojana in the district of **Dhalai for 4 number of packages (4 road works & 4 LS Bridges) with estimated cost for ₹1474.14 lakh**, in district of **North Tripura for 3 number of packages (4 road works & 2 LS Bridges) with estimated cost for ₹1026.53 lakh** and in district of **Unakoti for 2 number of packages (4 road works) with estimated cost for ₹912.62 lakh** including maintenance for five years from the eligible contractor of appropriate class registered with PWD / TTAADC / MES / CPWD / Railway / Other State PWD / Central & State Public Sector undertakings\*.

**Availability of Bid Documents and mode of submission:** The bid document is available online and should be submitted online in [www.pmgstenderstrp.gov.in](http://www.pmgstenderstrp.gov.in). The bidder would be required to register in the web-site which is free of cost. For submission of the bids, the bidder is required to have a valid Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities. The bidders are required to submit (a) original Demand Draft towards the cost of bid document and (b) original bid security in approved form and (c) original affidavit regarding correctness of information furnished with bid document as per provisions of Clause 4.4 B (a) (ii) of ITB with **Empowered Officer, Tripura RRDA, 7<sup>th</sup> Block, 2<sup>nd</sup> Floor, Secretariat Building, Agartala**, on a date not later than three working days after the opening of technical qualification part of the Bid i.e., upto **27/11/2018 till 1500 Hours** either by registered post or by hand, failing which the bids shall be declared non-responsive.
