Earnest Money and Bid Fee are to be drawn separately on State Bank of India or any other scheduled Bank guaranteed by the RBI, in the shape of "**Deposit at call**" / "**Demand Draft**" in favour of the **Executive Engineer, Mohanpur Division, PWD(R&B), Mohanpur, West Tripura.**

Demand drafts furnished as above shall be valid for a minimum period of **3 (three) months** from the last date of publishing of bid. Bid Fee of **Rs.5,000.00 (Rupees five thousand)** only, shall be accepted as "Deposit at call"/"Demand Draft" and is Non-Refundable.

The Bidders will have to upload the scan copy of the drawn "Demand Draft"/ "Deposit at call" (as a single PDF file of 100 dpi resolution), against the related Bid fee & Earnest money, along with the bid.
