The e-Procurement website will not allow any Bidder to attempt bidding, after the scheduled date and time. **Submission of bids physically is not permitted.**

Earnest Money and Bid Fee are to be drawn separately on State Bank of India or any other scheduled Bank guaranteed by the RBI, in the shape of "Deposit at call"/ "Demand Draft" in favour of the **Executive Engineer, Mohanpur Division, PWD(R&B), Mohanpur, West Tripura.**

Demand drafts furnished as above shall be valid for a minimum period of **3 (three) months** from the last date of publishing of bid. Bid Fee of **₹5000.00 (Rupees five thousand)** only, shall be accepted as "Deposit at call"/"Demand Draft" and is Non-Refundable.
