- The Bidders shall scan (in 100 dps scan resolution) all the required documents, into PDF format for uploading as part of Bid.
- Bill of Quantity (BOQ), which is the Rate quoting sheet in Ms-excel shall be downloaded, filled up properly and uploaded in the bid after digital signing. The Bidder shall always open the BOQ sheet with Macros Enabled.
