
1. This Request for Proposals follows the General Procurement Notice for this Project that appeared in Development Business on 9 March 2017
2. The Government of India (hereinafter called "Borrower") has received financing from the International Bank for Reconstruction and Development (IBRD) (the "Bank") in the form of a loan (hereinafter called "loan" toward the cost of **National Hydrology Project (NHP)**. Public Works Department (Water Resources), Government of Tripura represented by the Executive Engineer, Water Resource Investigation Division, Public Works Department (Water Resource), Kunjaban, Agartala, Government of Tripura ("the Client"), an implementing agency under the NHP, intends to apply a portion of the proceeds of this loan to eligible payments under the contract for which this Request for Proposals is issued. Payments by the Bank will be made only at the request of the Borrower and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the loan agreement. The loan agreement prohibits a withdrawal from the loan account for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of the Bank, is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations. No party other than the Borrower/Client shall derive any rights from the loan agreement or have any claims to the proceeds of the loan.
3. The Client now invite proposals to provide the following Consulting Services (hereinafter called "Services"): **Development of Flood Warning System for Agartala and Kailashahar, Tripura**. More details on the Services are provided in the Terms of Reference (Section 7)
4. A firm/ Joint Venture will be selected under **Least-Cost Selection (LCS)** and as per procedures described in this RFP, in accordance with the policies of the Bank detailed in the Consultants' Guidelines which can be found at the following website: www.worldbank.org/procure.
